PARENT AGREEMENT CONTRACT

At Fillmore Girls Fastpitch, our mission is to provide a wholesome, supportive environment for young athletes to develop character, sportsmanship, and teamwork through healthy athletic competitions. We are a nonprofit volunteer-run organization, and the success of our league depends on the cooperation and support of every parent.

Please review and accept this agreement as a commitment to uphold the values and expectations of our league.

PARENT CONDUCT EXPECTATIONS

We ask that all parents and guardians abide by the following rules:

- I understand that **sportsmanship and cooperation** are priorities. I will not tolerate or contribute to any behavior on the field or in the stands that disrupts the spirit of fair play.
- I will not use or permit **abusive language, profanity, or aggressive behavior** at any league event.
- I understand that **alcoholic beverages and smoking** are strictly prohibited in or near the Fillmore Girls Softball fields, dugouts, and common areas.
- I will ensure that all **social media use** related to the league, including but not limited to Facebook, Instagram, Twitter, TikTok, and other platforms, reflect respect and positivity. I will not post negative comments, photos, or content related to players, coaches, officials, board members, or parents. Harassment, cyberbullying, or defamation will not be tolerated and may result in removal from the league.
- I accept responsibility for the **conduct of any guests** I bring to league events.
- I understand that **Fillmore Girls Fastpitch is a volunteer program**, and I will do my part to keep the fields and facilities clean.
- I will ensure my child arrives **on time** to games and practices and will make timely arrangements for pickup.

COMMUNICATION RESPONSIBILITY

If my contact information changes during the season, I understand that it is **my responsibility to notify a board member** directly with updated details.

VOLUNTEER COMMITMENT (Snack Bar & Fireworks Booth)

To support the league's operations:

- Each family must provide a **\$100 deposit or opt for a buyout** for the snack bar obligation during the Spring Regular Season.
- **All-Star participants** are additionally required to work a **4-hour fireworks booth shift**.
- Each player requires:
 - **One (1) snack bar shift** of 2 hours
 - **One (1) fireworks booth shift** of 4 hours (All-Star families only)

Failure to fulfill these volunteer shifts will result in forfeiture of your snack bar/fireworks deposit.

FUNDRAISING POLICY

Participation in fundraising is **mandatory for all All-Star families**. Registration fees only cover a portion of league costs. Parent involvement in fundraising allows us to improve our fields, equipment, and overall experience while keeping registration fees accessible for all families.

REGISTRATION & PAYMENT POLICY

- **Full payment** of the registration fee is required **before** a player is assigned to a team.

REFUND POLICY

We strive to be fair and flexible in refund situations. The refund schedule is as follows:

- From **the first registration date through the final registration date: 75% refund**
- From **day after final registration through team formation: 50% refund**
- **After team formation: NO REFUND**
